The Fort ST. John Community Arts Council has worked throughout 1987 to maintain a consistent level of service to the community and arts group members while supporting the development of the future Arts Centre. Fundraising efforts have been designed to contribute to the capital of the new Arts Centre. New programs for further arts development have been put on hold until the fundraising energies can, once again, be focused on arts programs rather than facilities.

The current level of assistance from the City Council has allowed the Arts Council to complete all on going activities and services. In 1987, the Arts Council:

- -maintained the Artspace Ticket and Information Centre
- -improved and extended Artspace Classes
- -assisted twelve of the twenty-six member groups with financial support
- -conducted the highly successful Partly Arts concert series
- -sponsored and hosted the Regional Peace Country Arts Conference
- -completed the Artvark Summer Arts Program for the fourth consecutive year
- -encouraged arts activities and events of all art-related groups and individuals in the community
- -informed individual artists on sources of funds and means of publicizing their artwork
- -provided entertainment and exhibits for specialized conferences and community events

The Fort St. John Community Arts Council would like to continue the cooperation between the arts community and City Council with the same level of funding received in the last five years of \$5,500 annually.

We look forward to discussing with you the arts involvement in our community.

Dear Mayor Walsh and City Council Members,

The Fort St. John Arts Council would like to thank you for the support received for the operation of the arts in the community. The Arts Council with twenty-six member groups representing thousands of residents has received \$5,500 each year since 1983 and the Artspace which serves the entire community has received funds to cover the rent in the past four years. Enclosed is a detailed list of funds provided to member groups since 1980. In 1988, the total funds contributed to the arts by the City of Fort St. John was \$15,100. This contribution has assisted in generating over \$250,000 in arts spending in the community in 1988.

The Arts Council and the Artspace projected budgets to 1990 are enclosed. The immediate change to 1989 is seen in the rent increase imposed upon the Artspace by J.B. Holdings. The Artspace must now pay \$900 each month which also covers light and heat. The Arts Council is able to carry on the current programs with the Artspace but can not raise the additional \$1200 to provide the additional rent funds.

The Arts Council can continue to provide the current level of service to the community through the Artspace with additional support from the City.

The Fort St. John Community Arts Council has worked toward expansion of arts development in the community during the last year.

Assisted - 13 of the 28 member groups with financial support.

Operated - the Artspace Ticket and Information Centre assisting 25 Arts groups and 12 non-arts groups.

Conducted - the Artspace Classes representing 1050 registrations in 1989-90.

Presented - Partly Arts Concert Series enjoyed by 1200 audience members.

Supported - The progress of Arts Centre development

Awarded - Top students in Music, Drama, Creative
Writing and Art at Northern Lights College
and North Peace Secondary School.

The Arts Council has used the funds from City Council to assist the member groups whose combined expenses of \$302,000 generate (x 2.5 lowest economic index factor) \$755,000 economic impact in Fort St. John.

Dear City Council

Thank you for allowing us to bring you up to date on the activities of the Fort St. John Community Arts Council on January 7,.199
Several questions arose during the presentation for which we have found the answers.

The \$1500 receivable in the Artspace statement represents the final payment of office contract from the Arts Council budget. The cheque was written June 26, by the Arts Council but not deposited into the Artspace account until into the 90-91 financial year beginning July 1,1990.

The list of Arts Council groups receiving grants each year from the Arts Council is included. This information had not been included in the original package to City council this year.

The question of the GST is a concern for us. The increase of \$63 per month (\$756/year) on the rent was not included in the budget request. However, the GST will impact our budget in many areas which will place a strain on our already limited situation. If the City Council could include the GST in the rent request for the Artspace, the Arts Council could be better prepared to balance the 1990-91 budget.

Thank you for your support of arts development in Fort St. John.

The Fort St. John Community Arts Council has continued to work in the arts development in the North Peace during this past year. With the assistance of the City of Fort St. John we have been able to:

- Operate the Artspace Ticket and Information Centre assisting 23 arts groups 15 non-arts groups.
- Initiate the development of the Children's Festival for June 1992.
- Support the progress of the Cultural Centre development providing resources, meeting space and office services.
- Present the Partly Arts Concert Series of six touring concerts attracting an audience of 1700 people.
- Award top students in Music, Drama and Art at Northern Lights College and North Peace Secondary School and Miss Fort St. John Talent winner.
- Conduct Artspace Classes representing 1100 registrations in 1990-91.

The Artspace will be celebrating its 10 year Anniversary in 1992. Moving into the new North Peace Cultural Centre is an exciting 10 year milestone.

With the completion of the North Peace Cultural Centre, the Community Arts Council will experience an adjustment. Our role as an Advisory Board to the Cultural Centre will require additional effort in planning and policy and further commitment to Cultural Centre support.

The Arts Council will continue to use the City funds to support member groups development and activities. The Artspace rent will continue to be applied to the operation of the Artspace which will be part of the North Peace Cultural Centre after May 1992.

Artspace Ticket and Info Centre: \$13,476 - increase from 1991 of \$1,920


