The Peace-Liard Regional Juried Show is an annual event of the Peace-Liard Regional Arts Council with the assistance of the Assembly of BC Arts Councils. At an opening reception last Friday, Assembly President Sheila Simard addressed the artists and interested public. She explained the changes in the annual competition rules which only allows 15 works to be selected from the Peace Country. She also announced the Business Skills Workshop held on Sunday as the first attempt to cooperate with the Emily Carr College of Art to help local artists improve their skills. Sheila Simard is from Dawson Creek and will be Assembly President for three years.

Images & Objects XI BC's Largest Annual Juried Art Exhibition To Be Held in Trail

The Assembly of BC Arts Councils' eleventh annual provincial juried art exhibition, Images & Objects, will be held in Trail, May 26-30, 1993. Works will be selected for this exhibition from twelve regional qualifying shows to be held throughout BC between January and March: The Peace Liard Regional Juried Art Show is to be held in Tumbler Ridge, March 19-27, hosted by the Tumbler Ridge Community Arts Council.

The core group of jurors for Images & Objects XI is Carole Itter, Doreen Jensen, Richard Reid, Ann Rosenberg, Gordon Smith, Ian Thomas and Paul Wong, who will travel to regions in pairs. These jurors have demonstrated their commitment to community-based art and artists as well as their interest in assisting the Assembly, its Regional Arts Councils and participating artists in establishing a long-term vision for Images & Objects. The jurors have collectively worked with Assembly staff in the establishment of the parameters for this year's exhibition, which will encourage experimentation and development amongst community visual artists in BC.

In general, the jurors will not be selecting works based on their marketability, but rather be considering works that best exemplify the creative explorations being undertaken by an artist and how their passion, struggles, risks, skills, ideas and integrity are balanced in a completed work. There must be a sense of commitment and individual sensibility conveyed through the choice of ideas, processes and materials, resulting in the artist working out of a personal base that informs the work itself.

Images & Objects is more than just BC's largest annual juried art exhibition. For all artists entering, it is an opportunity to meet with professional jurors who will stimulate dialogue, give critiques and encouragement, and who will select works representing all areas of the province for inclusion in Images & Objects.

For those artists whose works are chosen to show in Images & Objects, it is an opportunity to be subsidized to attend the exhibition, meeting other artists from throughout the province, discussing their work and broader issues concerning the art community, and where an extensive series of professional development workshops are available free of charge.

Images & Objects XI is the visual arts component of the BC Festival of the Arts, the largest Festival of its kind in Canada, involving over 100,000 individuals throughout the province, and is supported by the Province of BC, Ministry of Tourism and Ministry Responsible for Culture, Hon. Darlene Marzari, Minister.
