Work must have been completed after January 1987 and not previously entered in a Regional Juried Art Show.

Maximum of two works per artist can be entered in each of the categories listed below:

1. Oil or acrylic painting - framed
2. Pastel, watercolour oil pastel - glazed and framed
3. Drawing: pen, pencil, conté, charcoal or mixed media -
glazed and framed
4. Print: any medium - glazed and framed
5. Calligraphy - suitably prepared for display
6. Ceramics - fired clay, glazed or unglazed
7. Sculptures or carvings
8. Fabric Art
9. Photography: state whether printed or developed by the
artist
10. Collage: multi-media two dimensional effect

WORKS DIFFICULT TO SHIP OR MOVE DUE TO SIZE, WEIGHT OR FRAGILITY
SHOULD NOT BE ENTERED

Works must be delivered no later than March 16th by 5 p.m. to Rooms 4 & 5 at the Tumbler Ridge Community Centre. Complete Information Forms must be firmly attached to the back or the underside of each work. Forms are included on the entry application.

Artists will be notified of the results of the jury selection. Selected works will be packed by the committee and shipped to the B.C. Assembly of Arts Council "Images and Objects" show in Kimberly. Selected works will hang in the TRCAC Gallery March 26 - May 5th, 1988.
